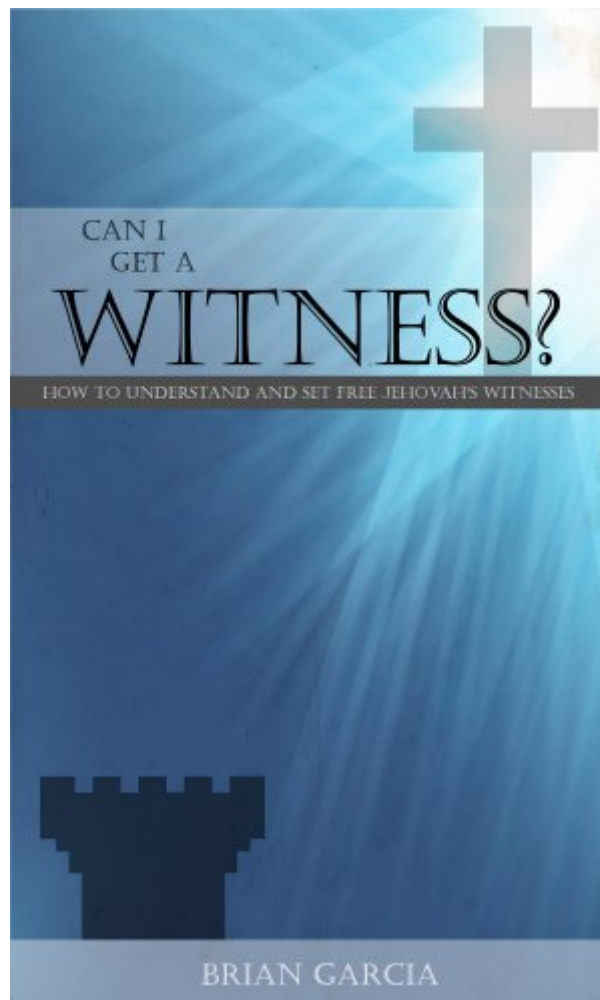

Furthermore, he is also a very good student of scripture and theology and makes very good arguments for orthodox Christianity. He also gives some very good advice for how to talk with Jehovah's Witnesses. My only slight quibble is that the book is obviously self published and could have used a little professional editing. The slight grammar / spelling mistakes every now and then do give the book a sense of coming from a real person and not just a professional theologian. I have read several books regarding winning JW's to Christ. I appreciate the author's humble attitude to his family and ex-JW's. I also greatly appreciated his first-hand testimonials, as I believe that this has helped me personally to understand the mindset of the JW. While this book is not intended to be an exhaustive study of the Watchtower Society, it does give a brief exposition of the primary doctrines that will help, not only in understanding the JW's perspective, but also in solidifying our own. There is one downside to the book, and that is that there are several grammatical errors in the book that slows the reader slightly down to make sure that he is understanding what the author is saying. A corrected, revised edition would be beneficial. All in all, however, a wonderful book to those, who like myself, have a heart for the JW.

This book told me exactly what i wanted to know. Mostly how to really understand where the Jehovah Witness is coming from, and how they view things. Great research on watchtower history, and tips on how to have fruitful dialogue while trying to witness to a witness. This book is loaded with Scripture from many different Bible versions, and utilizes the New World Translation, the Jehovah's Witnesses' own translation, to Biblically counter the Jehovah's Witnesses' top doctrines. I am an avid reader myself, and I'll tell you that this is my favorite book on Jehovah's witnesses and will most likely stay that way for a very long time, not only because I am now even more prepared to defend my faith to an evangelizing Jehovah's Witness than I was before, but also because this isn't a book bashing Jehovah's Witnesses' but rather a superb book that should be read by Jehovah's Witnesses to see, out of love and compassion, why a born-again Christian has the reservations he/she has with Jehovah's Witness theology and why a born-again Christian has a sincere belief in sound Biblical Christianity. Moreover, as a Christian intellectual, whenever Brian makes a point throughout the book, he supports every claim with names, dates, stats, facts, observations, testable claims, demonstrated quotes from scripture, magazines, and other works, predicts what we should find if true/untrue, ect, repeatedly throughout the entire book. This book is an excellent work in Christian apologetics, making this an exquisite recourse for even well-learned Christian apologists seeking material in the Jehovah's Witnesses category, as well as Christians with a more casual knowledge of Scripture and history, and Jehovah's Witnesses themselves interested in seeing a loving but firm refutation of the Biblically unsound Jehovah's Witness theology, along with a beautiful personal testimony at the end.

This is a must-read for anyone trying to reach out to Jehovah's Witnesses. Also highly valuable for those who have a JW friend or family member. While grammar needs further proofreading and editing, the content is pure gold. This book uniquely encourages a caring, rather than confrontational approach to influencing Jehovah's Witnesses.
