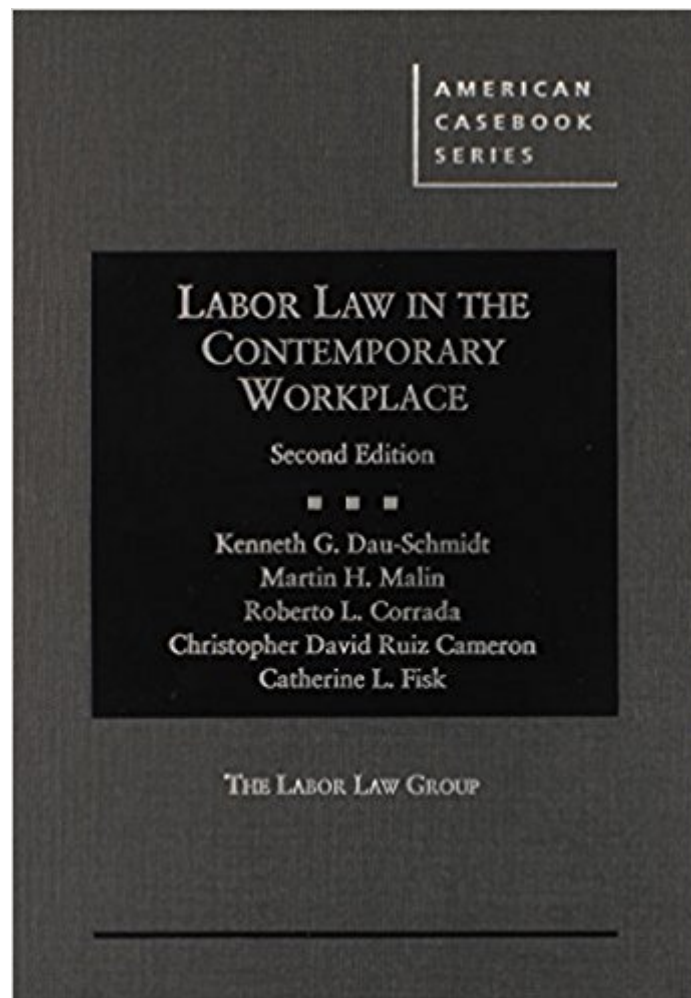

Labor Law in the Contemporary Workplace is organized around contemporary problems as a means of teaching the core principles of labor law. The second edition takes account of changes in the law since the first edition was published and in particular new interpretations of the National Labor Relations Act by the National Labor Relations Board and recent state restrictions on public sector collective bargaining.
